- the Health Protection Surveillance Centre (HPSC) has been notified of 1 additional death from COVID-19

- there have now been 26,838 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC led to the denotification of 2 confirmed cases. The figure of 26,838 reflects this
