- the Health Protection Surveillance Centre (HPSC) has been notified of 1 additional death from COVID-19
- there have been 1,774 COVID-19 related deaths in Ireland

- there have now been 26.838 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC led to the denotification of 3 confirmed cases. The figure of 26,838 reflects this
