## The latest news as of 5.45pm on Friday 14 August

67 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has not been notified of any additional deaths from COVID-19
- there have been 1,774 COVID-19 related deaths in Ireland
- 67 additional cases of COVID-19 have been confirmed
- there have now been 26,995 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC led to the denotification of one confirmed case. The figure of 26,995 reflects this
