The latest news as of 6pm on Saturday 15 August

200 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has not been notified of any additional deaths from COVID-19
- there have been 1,774 COVID-19 related deaths in Ireland
- 200 additional cases of COVID-19 have been confirmed
- there have now been 27,191 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC led to the denotification of four confirmed cases. The figure of 27,191 reflects this
