New public health measures were announced on Tuesday 18 August. [You can see those measures here.](#)

1 death and 190 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed that 1 person with COVID-19 in Ireland has died
- there have been 1,775 COVID-19 related deaths in Ireland
- 190 additional cases of COVID-19 have been confirmed
- there have now been 27,499 confirmed cases of COVID-19 in Ireland

- validation of data at the HPSC led to the denotification of 4 confirmed cases. The figure of 27,499 reflects this
