The latest news as of 6pm on Wednesday 19 August

2 deaths and 54 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed that 2 people with COVID-19 in Ireland have died
- there have now been 1,775 COVID-19 related deaths in Ireland
- validation of data at the HPSC led to the denotification of 2 deaths. The figure of 1,775 reflects this
- 54 additional cases of COVID-19 have been confirmed
- there have now been 27,547 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC led to the denotification of 6 confirmed cases. The figure of 27,547 reflects this
