The latest news as of 6.45pm on Thursday 20 August

1 death and 136 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed that 1 person with COVID-19 in Ireland has died
- there have now been 1,776 COVID-19 related deaths in Ireland
- 136 additional cases of COVID-19 have been confirmed
- there have now been 27,676 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC has resulted in the denotification of 7 confirmed cases. The figure of 27,676 confirmed cases reflects this
