61 cases confirmed

- the Health Protection Surveillance Centre (HPSC) has not been informed of any additional deaths among people with COVID-19 in Ireland
- there have been 1,777 COVID-19 related deaths in Ireland
- 61 additional cases of COVID-19 have been confirmed
- there have now been 27,969 confirmed cases of COVID-19 in Ireland
