#### The latest news as of 6pm on Wednesday 26 August

164 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has not been informed of any additional deaths among people with COVID-19 in Ireland
- there have been 1,777 COVID-19 related deaths in Ireland
- 164 additional cases of COVID-19 have been confirmed
- there have now been 28,363 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC has resulted in the denotification of 2 confirmed cases. The figure of 28,363 confirmed cases reflects this
