The latest news as of 5.45pm on Tuesday 15 September

3 deaths and 357 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 3 additional deaths among people with COVID-19 in Ireland
- there have been 1,787 COVID-19 related deaths in Ireland
- 357 additional cases of COVID-19 have been confirmed
- there have now been 31,549 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC has resulted in the denotification of 2 confirmed cases. The figure of 31,549 confirmed cases reflects this
