## The latest news as of 6.30pm on Wednesday 16 September

3 deaths and 254 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 3 additional deaths among people with COVID-19 in Ireland
- there have been 1,788 COVID-19 related deaths in Ireland
- validation of data at the HPSC has resulted in the denotification of 2 deaths. The figure of 1,788 reflects this
- 254 additional cases of COVID-19 have been confirmed
- there have now been 31,799 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC has resulted in the denotification of 4 confirmed cases. The figure of 31,799 confirmed cases reflects this
