The latest news as of 5.25pm on Friday 18 September

3 deaths and 253 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 3 additional deaths among people with COVID-19 in Ireland
- there have been 1,792 COVID-19 related deaths in Ireland
- 253 additional cases of COVID-19 have been confirmed
- there have now been 32,271 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC has resulted in the denotification of 5 confirmed cases. The figure of 32,271 confirmed cases reflects this
