The latest news as of 5.30pm on Saturday 19 September

274 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has not been informed of any additional deaths among people with COVID-19 in Ireland
- there have been 1,792 COVID-19 related deaths in Ireland
- 274 additional cases of COVID-19 have been confirmed
- there have now been 32,538 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC has resulted in the denotification of 7 confirmed cases. The figure of 32,538 confirmed cases reflects this
