## The latest news as of 5.30pm on Sunday 20 September

396 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has not been informed of any additional deaths among people with COVID-19 in Ireland
- there have been 1,792 COVID-19 related deaths in Ireland
- 396 additional cases of COVID-19 have been confirmed
- there have now been 32,933 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC has resulted in the denotification of 1 confirmed cases. The figure of 32,933 confirmed cases reflects this.
