## The latest news as of 5.30pm on Monday 21 September

188 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has not been informed of any additional deaths among people with COVID-19 in Ireland
- there have been 1,792 COVID-19 related deaths in Ireland
- 188 additional cases of COVID-19 have been confirmed
- there have now been 33,121 confirmed cases of COVID-19 in Ireland
