The latest news as of 6pm on Wednesday 23 September

2 deaths and 234 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 2 additional deaths among people with COVID-19 in Ireland
- there have been 1,794 COVID-19 related deaths in Ireland
- 234 additional cases of COVID-19 have been confirmed
- there have now been 33,675 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC has resulted in the denotification of 3 confirmed cases. The figure of 33,675 confirmed cases reflects this
