## The latest news as of 5.30pm on Thursday 24 September

3 deaths and 324 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 3 additional deaths among people with COVID-19 in Ireland
- there have now been 1,797 COVID-19 related deaths in Ireland
- 324 additional cases of COVID-19 have been confirmed
- there have now been 33,994 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC has resulted in the denotification of 6 confirmed cases. The figure of 33,994 confirmed cases reflects this
