The latest news as of 5.45pm on Friday 25 September

326 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has not been informed of any additional deaths among people with COVID-19 in Ireland
- there have been 1.797 COVID-19 related deaths in Ireland
- 326 additional cases of COVID-19 have been confirmed
- there have now been 34,315 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC has resulted in the denotification of 6 confirmed cases. The figure of 34,315 confirmed cases reflects this
