# The latest news as of 5.30pm on Saturday 26 September

5 deaths and 248 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 5 additional deaths among people with COVID-19 in Ireland
- there have now been 1,802 COVID-19 related deaths in Ireland
- 248 additional cases of COVID-19 have been confirmed
- there have now been 34,560 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC led to the denotification of 3 confirmed cases. The figure of 34,560 confirmed cases reflects this
