## The latest news as of 6pm on Tuesday 29 September

1 death and 363 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 1 additional death among people with COVID-19 in Ireland
- there have now been 1,803 COVID-19 related deaths in Ireland
- 363 additional cases of COVID-19 have been confirmed
- there have now been 35,740 confirmed cases of COVID-19 in Ireland
