The latest news as of 6pm on Wednesday 30 September

1 death and 429 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 1 additional death among people with COVID-19 in Ireland
- there have now been 1,804 COVID-19 related deaths in Ireland
- 429 additional cases of COVID-19 have been confirmed
- there have now been 36,155 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC has resulted in the denotification of 14 confirmed cases. The figure of 36,155 confirmed cases reflects this
