## The latest news as of 5.45pm on Thursday 1 October

4 deaths and 442 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 4 additional deaths among people with COVID-19 in Ireland
- there have been 1,806 COVID-19 related deaths in Ireland
- validation of data at the HPSC has resulted in the denotification of 2 deaths. The figure of 1,806 reflects this
- 442 additional cases of COVID-19 have been confirmed
- there have now been 36,597 confirmed cases of COVID-19 in Ireland
