## The latest news as of 5.45pm on Friday 2 October

1 death and 470 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 1 additional death among people with COVID-19 in Ireland
- there have been 1,801 COVID-19 related deaths in Ireland
- validation of data at the HPSC has resulted in the denotification of 6 deaths. The figure of 1,801 reflects this
- 470 additional cases of COVID-19 have been confirmed
- there have now been 37,063 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC has resulted in the denotification of 4 cases. The figure of 37,063 reflects this
