The latest news as of 6pm on Monday 5 October

518 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has not been informed of any additional deaths among people with COVID-19 in Ireland
- there have been 1,810 COVID-19 related deaths in Ireland
- 518 additional cases of COVID-19 have been confirmed
- there have now been 38,549 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC has resulted in the denotification of 1 confirmed case. The figure of 38,549 confirmed cases reflects this
