The latest news as of 6.15pm on Tuesday 6 October

1 death and 432 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 1 additional death among people with COVID-19 in Ireland
- there have been 1,811 COVID-19 related deaths in Ireland
- 432 additional cases of COVID-19 have been confirmed
- there have now been 38,973 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC has resulted in the denotification of 8 confirmed cases. The figure of 38,973 confirmed cases reflects this
