The latest news as of 6pm on Wednesday 7 October

5 deaths and 611 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 5 additional deaths among people with COVID-19 in Ireland
- there have been 1,816 COVID-19 related deaths in Ireland
- 611 additional cases of COVID-19 have been confirmed
- there have now been 39,584 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC has resulted in the denotification of 8 confirmed cases. The figure of 39,584 confirmed cases reflects this
