## The latest news as of 5.45pm on Thursday 8 October

1 death and 506 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 1 additional death among people with COVID-19 in Ireland
- there have been 1,817 COVID-19 related deaths in Ireland
- 506 additional cases of COVID-19 have been confirmed
- there have now been 40,086 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC has resulted in the denotification of 4 confirmed cases. The figure of 40,086 confirmed cases reflects this
