The latest news as of 6.15pm on Friday 9 October

5 deaths and 617 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 5 additional deaths among people with COVID-19 in Ireland
- there have been 1,821 COVID-19 related deaths in Ireland
- validation of data at the HPSC has resulted in the denotification of 1 death. The figure of 1,821 deaths reflects this
- 617 additional cases of COVID-19 have been confirmed
- there have now been 40,703 confirmed cases of COVID-19 in Ireland
