The latest news as of 6.30pm on Monday 12 October

1 death and 825 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 1 additional death among people with COVID-19 in Ireland
- there have been 1,827 COVID-19 related deaths in Ireland
- 825 additional cases of COVID-19 have been confirmed
- there have now been 43,351 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC has resulted in the denotification of 2 confirmed cases. The figure of 43,351 confirmed cases reflects this
