## The latest news as of 6.30pm on Tuesday 13 October

3 deaths and 811 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 3 additional deaths among people with COVID-19 in Ireland
- there have been 1,830 COVID-19 related deaths in Ireland
- 811 additional cases of COVID-19 have been confirmed
- there have now been 44,159 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC has resulted in the denotification of 3 confirmed cases. The figure of 44,159 confirmed cases reflects this
