## The latest news as of 6.15pm on Wednesday 14 October

5 deaths and 1,095 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 5 additional deaths among people with COVID-19 in Ireland
- there have been 1,835 COVID-19 related deaths in Ireland
- 1,095 additional cases of COVID-19 have been confirmed
- there have now been 45,243 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC has resulted in the denotification of 11 confirmed cases. The figure of 45,243 confirmed cases reflects this
