# The latest news as of 5.30pm on Friday 16 October

3 deaths and 1.000 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 3 additional deaths among people with COVID-19 in Ireland
- there have been 1,841 COVID-19 related deaths in Ireland
- 1,000 additional cases of COVID-19 have been confirmed
- there have now been 47,427 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC has resulted in the denotification of 2 confirmed cases. The figure of 47,427 confirmed cases reflects this
