## The latest news as of 5.30pm on Sunday 18 October

3 deaths and 1,283 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 3 additional deaths among people with COVID-19 in Ireland
- there have been 1,852 COVID-19 related deaths in Ireland
- 1,283 additional cases of COVID-19 have been confirmed
- there have now been 49,962 confirmed cases of COVID-19 in Ireland
