## The latest news as of 6pm on Monday 19 October

1,031 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has not been informed of any additional deaths among people with COVID-19 in Ireland
- there have been 1,852 COVID-19 related deaths in Ireland
- 1,031 additional cases of COVID-19 have been confirmed
- there have now been 50,993 confirmed cases of COVID-19 in Ireland
