## The latest news as of 5.30pm on Tuesday 20 October

13 deaths and 1,269 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 13 additional deaths among people with COVID-19 in Ireland
- there have been 1,865 COVID-19 related deaths in Ireland
- 1,269 additional cases of COVID-19 have been confirmed
- there have now been 52,256 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC has resulted in the denotification of 6 confirmed cases. The figure of 52,256 confirmed cases reflects this
