## The latest news as of 5.45pm on Wednesday 21 October

3 deaths and 1,167 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 3 additional deaths among people with COVID-19 in Ireland
- there have been 1,868 COVID-19 related deaths in Ireland
- 1,167 additional cases of COVID-19 have been confirmed
- there have now been 53,422 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC has resulted in the denotification of 1 confirmed case. The figure of 53,422 confirmed cases reflects this
