The latest news as of 5.45pm on Friday 23 October

7 deaths and 777 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 7 additional deaths among people with COVID-19 in Ireland
- there have been 1,878 COVID-19 related deaths in Ireland
- 777 additional cases of COVID-19 have been confirmed
- there have now been 55,261 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC has resulted in the denotification of 8 confirmed cases. The figure of 55,261 confirmed cases reflects this
