The latest news as of 5.30pm on Sunday 25 October

1.025 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has not been informed of any additional deaths among people with COVID-19 in Ireland
- there have been 1,882 COVID-19 related deaths in Ireland
- 1,025 additional cases of COVID-19 have been confirmed
- there have now been 57,128 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Sunday), 315 COVID-19 patients are hospitalised, of which 38 are in ICU. There have been 16 additional hospitalisations in the past 24 hours
