## The latest news as of 6pm on Monday 26 October

3 deaths and 939 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 3 additional deaths among people with COVID-19 in Ireland
- there have been 1,885 COVID-19 related deaths in Ireland
- 939 additional cases of COVID-19 have been confirmed
- there have now been 58,067 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Monday), 341 COVID-19 patients are hospitalised, of which 38 are in ICU. There have been 16 additional hospitalisations in the past 24 hours
