## The latest news as of 5.30pm on Thursday 29 October

6 deaths and 866 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 6 additional deaths among people with COVID-19 in Ireland
- there have been 1,902 COVID-19 related deaths in Ireland
- 866 additional cases of COVID-19 have been confirmed
- there have now been 60,297 confirmed cases of COVID-19 in Ireland
- as of 2pm today, 328 COVID-19 patients are hospitalised, of which 43 are in ICU. There have been 15 additional hospitalisations in the past 24 hours
