The latest news as of 6pm on Friday 30 October

6 deaths and 772 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 6 additional deaths among people with COVID-19 in Ireland
- there have been 1,908 COVID-19 related deaths in Ireland
- 772 additional cases of COVID-19 have been confirmed
- there have now been 61,059 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Friday), 325 COVID-19 patients are hospitalised, of which 42 are in ICU. There have been 15 additional hospitalisations in the past 24 hours
