## The latest news as of 5pm on Friday 30 October

5 deaths and 416 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 5 additional deaths among people with COVID-19 in Ireland
- there have been 1,913 COVID-19 related deaths in Ireland
- 416 additional cases of COVID-19 have been confirmed
- there have now been 61,456 confirmed cases of COVID-19 in Ireland
- as of 2pm today 320 COVID-19 patients are hospitalised, of which 41 are in ICU. 19 additional hospitalisations in the past 24 hours.
