The latest news as of 4.45pm on Sunday 1 November

2 deaths and 552 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 2 additional deaths among people with COVID-19 in Ireland
- there have been 1,915 COVID-19 related deaths in Ireland
- 552 additional cases of COVID-19 have been confirmed
- there have now been 62,002 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Sunday), 330 COVID-19 patients are hospitalised, of which 47 are in ICU. There have been 17 additional hospitalisations in the past 24 hours
