## The latest news as of 5.45pm on Tuesday 3 November

5 deaths and 322 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 5 additional deaths among people with COVID-19 in Ireland
- there have been 1,922 COVID-19 related deaths in Ireland
- 322 additional cases of COVID-19 have been confirmed
- there have now been 63,048 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Tuesday), 296 COVID-19 patients are hospitalised, of which 42 are in ICU. There have been 14 additional hospitalisations in the past 24 hours
