### The latest news as of 5.45pm on Friday 6 November

8 deaths and 499 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 8 additional deaths among people with COVID-19 in Ireland
- there have been 1,940 COVID-19 related deaths in Ireland
- 499 additional cases of COVID-19 have been confirmed
- there have now been 64,538 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Friday), 292 COVID-19 patients are hospitalised, of which 37 are in ICU. There have been 24 additional hospitalisations in the past 24 hours
