The latest news as of 5pm on Saturday 7 November

5 deaths and 335 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 5 additional deaths among people with COVID-19 in Ireland
- there have been 1,945 COVID-19 related deaths in Ireland
- 335 additional cases of COVID-19 have been confirmed
- there have now been 64,855 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Saturday), 284 COVID-19 patients are hospitalised, of which 40 are in ICU. There have been 23 additional hospitalisations in the past 24 hours
