The latest news as of 5.45pm on Sunday 8 November

2 deaths and 542 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 2 additional deaths among people with COVID-19 in Ireland
- there have been 1,947 COVID-19 related deaths in Ireland
- 542 additional cases of COVID-19 have been confirmed
- there have now been 65,394 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Sunday), 283 COVID-19 patients are hospitalised, of which 39 are in ICU. There have been 13 additional hospitalisations in the past 24 hours
