## The latest news as of 5.30pm on Monday 9 November

1 death and 270 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 1 additional death among people with COVID-19 in Ireland
- there have been 1,948 COVID-19 related deaths in Ireland
- 270 additional cases of COVID-19 have been confirmed
- there have now been 65,659 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Monday), 291 COVID-19 patients are hospitalised, of which 39 are in ICU. There have been 12 additional hospitalisations in the past 24 hours
