## The latest news as of 5.45pm on Wednesday 11 November

2 deaths and 362 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 2 additional deaths among people with COVID-19 in Ireland. Of the deaths reported today, 1 occurred in October and 1 remains under investigation
- there have been 1,965 COVID-19 related deaths in Ireland
- 362 additional cases of COVID-19 have been confirmed
- there have now been 66,247 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Wednesday), 280 COVID-19 patients are hospitalised, of which 38 are in ICU. There have been 21 additional hospitalisations in the past 24 hours
