## The latest news as of 6pm on Thursday 12 November

1 death and 395 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 1 additional death among people with COVID-19 in Ireland
- there have been 1,965 COVID-19 related deaths in Ireland
- 395 additional cases of COVID-19 have been confirmed
- there have now been 66,632 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Thursday), 279 COVID-19 patients are hospitalised, of which 39 are in ICU. There have been 20 additional hospitalisations in the past 24 hours
